**PAYMENT TERMS AND CANCELLATION:** The deposit is \$2,000.00 upon application for enrollment (includes \$200.00 non-refundable application fee). It is understood that after registration and deposit of \$2000 the remaining tuition and fees will be divided into equal monthly installments. The final installment will be in May. All tuition and fees are fully refundable (less the \$200.00 application fee) until Jan. 1, 2010. Thereafter, there will be a cancellation fee of \$1,000.00 from January 1st to February 28th, \$2,000.00 from March 1st to April 30th, and \$3,500.00 from May 1st to May 31st. All payments other than the cancellation fee will be refunded. After June 1st there will be no refunds except for verified medical reasons. In this case, 50% of the pro-rated amount paid will be refunded.

**CONTRACT:** Please read the following information carefully.

1. The Camper's Fund Account is a one time charge required for each camper along with the tuition. This account provides for all day trips, the big trip, yearbook, bunk photos, and special events.
2. The Personal Spending Account is required for each camper along with the tuition. This account provides all personal spending money during day trips and the big trip. Billed amounts are outlined in the Parent Handbook.
3. The camp is not responsible for campers' equipment or personal belongings while in transit or at camp. Camp Lenox recommends that no valuable items such as watches, rings, expensive cameras, etc. be brought to camp.
4. Gratuities, in any form, for staff members or camp personnel are prohibited. Parents are expected to adhere to this important regulation.
5. My child has permission to participate in all camp programs, excursions and special outings as planned and supervised by Camp Lenox.
6. We fully understand the Camp reserves the right to dismiss at its sole discretion any camper whose condition, conduct, influence or behavior is deemed by the camp unsatisfactory or detrimental to the best interests of the Camp or who violates the Camp Rules and Regulations. Also, no refunds are to be made for campers dismissed for misconduct or disciplinary reasons. Reoccurring misconduct and illegal acts (such as using non-prescription drugs, smoking, and consuming alcoholic beverages) are prohibited. Violations of these prohibitions, as well as any other non-conforming or illegal behavior, constitutes ground for dismissal from camp.
7. For good and valuable consideration we hereby consent to and authorize the reproduction, publication and use by Camp Lenox and the American Camping Association for advertising, commercial, or any other purposes of any photograph or likeness of my/our child.
8. This enrollment application shall take effect and become binding when signed by a parent and accepted by Camp. All claims or disputes asserted by camper or parent against the Camp and arising from or related to this agreement shall be brought and maintained in the courts of the Commonwealth of Massachusetts (county of Berkshire), and parent expressly submits to the jurisdiction of such courts. The substantive law of the Commonwealth of Massachusetts will govern such disputes without regard to conflict of law rules. Any individual bringing legal action against Camp, in which action is decided in favor of camp, will be responsible for all legal fees, court costs and costs of the Camp, its owners, and employees.
9. Medical care will be provided by the camp physician and is included in the tuition. We acknowledge that the camp does not maintain any health or medical insurance, which would cover the camper while attending camp. The parent or legal guardian shall be responsible for the cost of all medical treatment, drugs and the like provided to their child during the camping season. Prescription medications will be billed to the parents. The camp shall not be responsible for any injuries that may be sustained by your child while participating in any activity at Camp unless such injury is directly caused by the gross negligence or willful acts of the Camp. The Camp will not be responsible for the personal health and well-being of children whose health forms are not submitted prior to the arrival of the child at Camp, or if the emergency release form is not signed by the parent.

**FOR CREDIT CARD PAYMENT ONLY:** Please charge my Visa/MasterCard (please circle one) in accordance with the deposit and payment schedule contained on the Registration Contract. It is understood that after registration and a deposit of \$2000, the remaining credit card balance will be processed in equal monthly payments. The final installment will be processed in May.
