CODE OF CONDUCT FOR TEEN CAMP

Due to a wide range of value systems and behavior that today's children are exposed to, we feel it necessary to state clearly our code of behaviors. While we do not pass judgement on anyone's lifestyle choices or needs for expression, we find the following codes most conducive to a successful and harmonious summer.

I will promote the creation of harmonious camp community based on mutual respect and sense of personal well being. I have read the following rules, designed to promote the health and safety of all participants, and have indicated my unqualified acceptance by my signature and that of my parent/guardian.

1. I will not possess, use, or distribute alcoholic beverages while at Camp Lenox or any other activities associated with above mentioned.
2. I will not possess, use, or distribute any illegal drugs or drug paraphernalia.
3. I will not smoke, consume or distribute tobacco products at Camp Lenox.
4. I will attend and participate fully in all camp activities unless otherwise agreed upon with group leader or activity leader. I will arrive on time, stay until the end, and remain at my activity until dismissed by an activity head or group leader.
5. I will not commit any illegal act. I understand that vandalism, disturbing the peace or other inappropriate behavior as determined by the adult leadership will not be tolerated. I understand that I will have to pay for any damage that I cause. I understand that no gambling in which money is exchanged is allowed.
6. I will abide by the curfews announced by group leaders. After each evening event, I will go directly to my cabin and remain there until the next morning.
7. I understand that no guests are allowed at camp, unless advance permission is granted by the directors, and that any unauthorized guests will be asked to leave immediately.
8. I refrain from inappropriate sexual behavior.
9. I agree to abide by any additional rules, which may be announced at camp, and to accept the consequences of their violation.
10. I agree not to leave camp grounds without proper adult supervision.
11. I understand that failure to live within these guidelines may cause the director to ask my parents that I be withdrawn from camp at my parent's expense.

I understand that these rules of behavior apply from the time I leave home for camp until I return from camp.
